xxvii. A trustee who is unable to be present at a meeting of the trustees may send his/her views on the agenda in writing and such expression of opinion shall be taken to be his/her vote on the matter concerned.

xxviii. The minutes of the proceedings of every meeting of the trustees shall be entered in a book to be kept for that purpose and signed by the Chairman of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.

xxix. Any trustee may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.
