xxviii. The minutes of the proceedings of every meeting of the trustees shall be entered in a book to be kept for that purpose and signed by the Chairman of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting.

xxix. Any trustee may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.

xxx. The surviving or continuing trustees may not withstanding any vacancy in their board act as trustees shall fall below two the minimum fixed by these presents, the trustees shall not, except for the purpose of filling any vacancy, act so long as the number is below the said minimum.

xxxi. The trustees for the time being shall elect form amongst them one Director and she shall hold office for two years, unless she/he resigns or refuses to act as Director or otherwise ceases to be trustee.
